### Tee-Ball Association of Western Australia Inc Endorsement G3 - 2014

It is hereby declared and agreed that Definition 7.11 Insured is deleted in its entirety and replaced with:

**7.11 Insured**

Means:

- 7.11.1 the Named Insured;
- 7.11.2 any Insured Person but only in respect of work performed while a principal, partner or director of the Named Insured
- 7.11.3 any person who is, during the Policy Period, an employee and/or volunteer of the Named Insured but only in respect of work performed while an employee of the Named Insured and on behalf of the Named Insured; and/or

Furthermore the policy is extended such that Insuring clause 1.1.4 provides cover in respect of the Insured's civil liability arising from a Claim made against any Insured by a Member of the Named Insured or Related Associations.

Furthermore 3.1.1 is deleted in its entirety and replaced with:

- 3.1.1 such loss is first discovered by the Named Insured during the Policy Period and is notified in writing to Us within sixty (60) days of the date of such discovery (but never beyond the expiry of the Policy Period);

Furthermore the following extension is added to the policy:

#### **Extended Reporting Period**

In the event that this policy is not renewed then the cover provided by Insuring Clause 1.1 shall be extended to any Claim first made against the Insured and notified to Us within the Extended Reporting Period, PROVIDED ALWAYS THAT:

1. cover afforded under this extension will not reinstate or increase the Indemnity Limit or extend the Policy Period; and
2. cover afforded under this extension will only apply to an act, error or omission committed by the Insured prior to the end of the Policy Period.

The cover provided by this extension does not apply if this policy is cancelled.

For the purposes of this endorsement:

Extended Reporting Period means the period commencing immediately following the end of the Policy Period and finishing sixty (60) days thereafter or when the Insured first effects another similar insurance policy (whichever is the earlier).

Member means a member as defined in the Named Insured's governing articles or rules and includes any past, present or prospective members of the Named Insured.

Related Association means a not for profit organization other than a Named Insured that is notified and accepted by Us and directly affiliated with a Named Insured, any additions of similar not for profit organizations during the Policy Period are automatically included provided they are directly affiliated with a Named Insured and incorporated.

To the extent that any parts of the above endorsement are found to be invalid or unenforceable, the remainder of each part of the endorsement shall remain in full force and effect.

Subject always to all other policy terms, conditions and exclusions which remain unaltered.
